NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 23-ERP-06 June 13, 2023

Petition of Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty Utilities for approval of its 2023 annual gas Emergency Response Plan filed pursuant to G.L. c. 164, § 85B and 220 CMR 19.04(1).

On May 13, 2023, Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty Utilities ("Company") filed its 2023 gas Emergency Response Plan ("ERP") with the Department of Public Utilities ("Department"). This filing was made pursuant to G.L. c. 164, § 85B and 220 CMR 19.04(1). The purpose of ERPs is to ensure that each gas company is adequately and sufficiently prepared to restore service to its customers in a safe and reasonably prompt manner during an emergency event. 220 CMR 19.00. The Department has docketed this matter as D.P.U. 23-ERP-06.

Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on **July 19, 2023**. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 23-ERP-06); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document.
