#### NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 23-122 December 5, 2023

Petition of the Gas Distribution Companies for review and approval by the Department of Public Utilities of their proposed revised tariffs, in compliance with D.P.U. 22-86.

In NSTAR Gas Company, D.P.U. 22-86, at 27 (July 20, 2023), the Department of Public Utilities ("Department") determined that capacity-exempt customers should be responsible for some portion of the costs related to meeting hourly flow requirements imposed by interstate pipelines. Accordingly, the Department directed the local gas distribution companies (Boston Gas Company d/b/a National Grid; NSTAR Gas Company and Eversource Gas Company of Massachusetts, each d/b/a Eversource Energy; Liberty Utilities (New England Gas Company) Corp. d/b/a Liberty; The Berkshire Gas Company; and Fitchburg Gas and Electric Light Company d/b/a Unitil) (collectively, "LDCs"), to develop tariff changes to eliminate any subsidization of capacity-exempt customers by sales and capacity-eligible customers for these costs. D.P.U. 22-86, at 27. On October 31, 2023, in accordance with the Department's directives, each of the LDCs filed with the Department a petition for approval of its proposed tariff changes necessary to recover a portion of the costs associated with meeting maximum hourly flow requirements from capacity-exempt customers. The Department docketed this matter as D.P.U. 23-122.

Any person interested in commenting on this matter may submit written comments to the Department no later than the close of business (5:00 p.m.) on **Thursday, January 4, 2024**. Please note that in the interest of transparency, any comments will be posted to our website as received and without redacting personal information, such as addresses, telephone numbers, or e-mail addresses. As such, members of the public should consider the extent of information they wish to share when submitting comments. The Department strongly encourages public comments to be submitted by email. If, however, a member of the public is unable to send written comments by email, a paper copy may be sent to Mark D. Marini, Secretary, Department of Public Utilities, One South Station, Boston, Massachusetts 02110.

Any person who desires to participate otherwise in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on **Wednesday**, **December 27**, **2023**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to

petitions to intervene must be filed by the close of business (5:00 p.m.) on the second business day after the petition to intervene was filed.

The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 23-122); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. Petition of the Gas Distribution Companies for review and approval by the Department of Public Utilities of their proposed revised tariffs, in compliance with D.P.U. 22-86.

Boston Gas Company d/b/a National Grid; NSTAR Gas Company and Eversource Gas Company of Massachusetts, each d/b/a Eversource Energy; Liberty Utilities (New England Gas Company) Corp. d/b/a Liberty; The Berkshire Gas Company; and Fitchburg Gas and Electric Light Company d/b/a Unitil) (collectively, "LDCs") are required to serve a copy of the attached Notice of Filing and Request for Comments ("Notice") no later than **December 12, 2023**, on the service lists in <u>Boston Gas Company</u>, D.P.U. 22-149; <u>NSTAR Gas Company</u>, D.P.U. 22-86; <u>Eversource Gas Company of Massachusetts</u>, D.P.U. 23-125; <u>Eversource Gas Company of Massachusetts</u>, D.P.U. 21-118; Liberty Utilities (New England Gas Company) Corp., D.P.U. 22-129; <u>The Berkshire Gas Company</u>, D.P.U. 22-148; and <u>Fitchburg Gas and Electric Light Company</u>, D.P.U. 23-25; and (2) on any person who has asked to be notified by the LDCs. Service may be by electronic distribution, which the Department finds reasonable and consistent with the public interest. Further, the Department finds that the notice period is reasonable and consistent with the public interest.

The LDCs shall prominently display the Notice on their websites from three business days following receipt of the Notice from the Department through the end of the comment period. The LDCs shall make return of service at the close of the comment period.
