## NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 20-14 February 10, 2020

Petition of Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty Utilities for approval of its Revenue Decoupling Adjustment Factors for the 2020 Off-Peak Period, May 1, 2020, through October 31, 2020.

On January 31, 2020, Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty Utilities ("Company") filed a petition with the Department of Public Utilities ("Department") for approval of its revenue decoupling adjustment factors ("RDAFs"), for effect May 1, 2020. This filing was made pursuant to: Liberty Utilities (New England Natural Gas Company) Corp., D.P.U. 15-75 (2016); Reduction in Federal Income Tax Rates, D.P.U. 18-15-A (2018); and the Company's revenue decoupling adjustment clause ("RDAC") tariff, M.D.P.U. No. 1025H. The RDAC allows the Company to modify, on a semi-annual basis, its base distribution rates as a result of changes in customer usage, in order to promote the efficient deployment of demand resources. See NSTAR Gas Company, D.P.U. 14-150, at 22-23 (2015). The Department has docketed this petition as D.P.U. 20-14.

The Company proposes RDAF charges of \$0.0384 per therm for residential customers, \$0.0453 per therm for commercial and industrial low-load customers, and \$0.0095 per therm for commercial and industrial high-load customers, effective May 1, 2020 through October 31, 2020. As a result of the proposed changes to the RDAF, the average residential heating customer using 29 therms per month during the off-peak period will experience a bill decrease of \$0.37, or \$0.99 percent as compared to the previously effective off-peak RDAF. The Company states that the average monthly bill impact for all rate classes at each class's average use will range from a decrease of 0.60 percent to 1.71 percent as compared to last year's off-peak period RDAF.
