NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 25-OGAF-LIB

April 2, 2025

Petition of Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty pursuant to G.L. c. 164 and 220 CMR 6.00 for approval of its revised 2024/2025 local distribution adjustment factor and peak gas adjustment factor filings, effective May 1, 2025.

On March 17, 2025, Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty ("Company" or "Liberty") filed with the Department of Public Utilities ("Department") its off-peak gas adjustment factors ("GAFs"), pursuant to G.L. c. 164 and 220 CMR 6.00. The filing includes the Company's off-peak GAF for effect May 1, 2025, through October 31, 2025, as well as the reconciliation of its 2024 off-peak period gas costs. The Company also filed a revision to its local distribution adjustment factor ("LDAF"), pursuant to G.L. c. 164 and 220 CMR 6.11. The filing includes updated residential assistance adjustment factor and an updated energy efficiency surcharge to revise the residential energy efficiency budget as directed in the Department's Order in 2025-2027 Three-Year Energy Efficiency Plans, D.P.U. 24-140 through D.P.U. 24-149, at 204 (February 28, 2025). The proposed rates are for effect May 1, 2025. The Department has docketed both of these petitions as D.P.U. 25-OGAF-LIB.

The tables below summarize the proposed LDAF rates in dollars per therm:

If the Department approves the Company's LDAFs as proposed, a typical residential heating customer in the Company's Fall River and North Attleboro service area will see an average monthly bill decrease of \$2.15, or 4.17 percent compared to the 2024 peak LDAF, and a typical residential heating customer in the Company's Blackstone service area will see an average monthly bill decrease of \$1.84, or 4.17 percent, compared to the 2024 peak LDAF. For specific bill impacts, please contact the Company as shown below.

For its Fall River/North Attleboro service area, the Company submitted a proposed off-peak GAF of \$0.2954 per therm for all customers. If the Department approves the Company's GAF as proposed, a typical residential heating (R-3) customer in the Company's Fall River/North Attleboro service area will see an average monthly bill increase of \$4.20 per month, or 7.90 percent, compared to the 2024 off-peak period.

For its Blackstone service area, the Company submitted a proposed off-peak GAF of \$0.6530 per therm for all customers. If the Department approves the Company's GAF as proposed, a typical residential heating (R-3) customer in the Company's Blackstone service area will see an average monthly bill increase of \$9.21 per month, or 21.91 percent, compared to the 2024 off-peak period. For specific bill impacts, please contact the Company as shown below.

Liberty may, at any time during the off-peak period, submit an amended GAF filing. The amended GAF filing must be submitted seven business days before the first billing cycle of the month in which it is proposed to take effect.
