NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 19-20

February 12, 2019

Petition of Liberty Utilities (New England Natural Gas Company) Corp., d/b/a Liberty Utilities for approval of its Revenue Decoupling Adjustment Factors for the 2019 Off-Peak Period, May 1, 2019, through October 31, 2019.

On February 1, 2019, Liberty Utilities (New England Natural Gas Company) Corp., d/b/a Liberty Utilities ("Company") filed a petition with the Department of Public Utilities ("Department") for approval of its revenue decoupling adjustment factors ("RDAFs"), for effect May 1, 2019. This filing was made pursuant to Liberty Utilities (New England Natural Gas Company) Corp., D.P.U. 15-75 (2016); and the Company's revenue decoupling adjustment clause ("RDAC") tariff, M.D.P.U. No. 1025G. The RDAC allows the Company to modify, on a semi-annual basis, its base distribution rates as a result of changes in customer usage, in order to promote the efficient deployment of demand resources. D.P.U. 10-114, at 33. The Department has docketed this petition as D.P.U. 19-20.

The Company proposes RDAF charges of \$0.0511 per therm for residential customers, \$0.0585 per therm for commercial and industrial low-load customers, and \$0.0129 per therm for commercial and industrial high-load customers, effective May 1, 2019 through October 31, 2019. As a result of the proposed changes to the RDAF, the average residential heating customer using 29 therms per month during the off-peak period will experience a bill increase of \$0.40 or 0.97 percent as compared to the previously effective off-peak RDAF. The Company states that the average monthly bill impact for all rate classes at each class's average use will range from an increase of 0.18 percent to an increase of 1.47 percent as compared to last year's off-peak period RDAF.
