### NOTICE OF FILING AND PUBLIC HEARING

D.P.U. 21-123 November 2, 2021

Petition of Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty, pursuant to G.L. c. 25, § 21, for approval by the Department of Public Utilities of its Three-Year Energy Efficiency Plan for 2022 through 2024.

On November 1, 2021, Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty ("Company" or "Liberty"), filed with the Department of Public Utilities ("Department"), a petition for approval of a three-year energy efficiency plan for calendar years 2022 through 2024 ("Three-Year Plan"). The Company filed its Three-Year Plan pursuant to An Act Relative to Green Communities, Acts of 2008, c. 169, § 11 ("Green Communities Act"). The Department docketed this matter as D.P.U. 21-123.

The Green Communities Act requires the Commonwealth's electric and gas distribution companies, and municipal aggregators with certified efficiency plans (together, "Program Administrators") to develop, in consultation with the Energy Efficiency Advisory Council ("Council"), plans that provide for the acquisition of all available energy efficiency and demand reduction resources that are cost effective or less expensive than supply. G.L. c. 25, § 21. The Company's proposed Three-Year Plan includes energy efficiency programs for residential, low-income, and commercial and industrial ("C&I") customers. The proposed Three-Year Plan also incorporates the Company's Residential Conservation Service filing pursuant to G.L. c. 164, App. § 2-7(h). On October 13, 2020, the Department approved the Company's acquisition of Blackstone Gas Company ("Blackstone Gas") and the Company will provide energy efficiency services to customers in the former Blackstone Gas service territory beginning January 1, 2022.

The Company's proposed budget for its Three-Year Plan is \$21,775,680 (<u>i.e.</u>, \$6,857,528 in 2022, \$7,135,367 in 2023, and \$7,782,784 in 2024) and includes a performance incentive. If the Company's Three-Year Plan is approved as proposed, the Company states that customers could experience the following bill impacts:

• A typical residential heating customer (R-3) of the Company using 122 therms per month in the peak period could experience a monthly peak bill increase of \$12.25 or

5.28 percent in 2021/2022; a monthly peak bill decrease of \$7.34 or 3.01 percent in 2022/2023; and a monthly peak bill increase of \$1.51 or 0.64 percent in 2023/2024;

- A typical former Blackstone Gas residential heating customer using 122 therms per month in the peak period could experience a monthly peak bill increase of \$8.21 or 3.39 percent in 2021/2022; a monthly peak bill decrease of \$7.34 or 3.02 percent in 2022/2023; and a monthly peak bill increase of \$1.51 or 0.62 percent in 2023/2024;
- A typical low-income residential heating customer (R-4) using 110 therms per month on average could experience a monthly peak bill increase of \$8.33 or 5.26 percent in 2021/2022; a monthly peak bill decrease of \$4.99 or 2.99 percent in 2022/2023; and a monthly peak bill increase of \$1.03 or 0.63 percent in 2023/2024;
- A typical former Blackstone Gas low-income residential heating customer using 110 therms per month on average could experience a monthly peak bill increase of \$5.57 or 3.37 percent in 2021/2022; a monthly peak bill decrease of \$4.99 or 3.00 percent in 2022/2023; and a monthly peak bill increase of \$1.03 or 0.62 percent in 2023/2024;
- Actual bill impacts may be lower for customers who participate in energy efficiency programs that lower their gas usage;
- Bill impacts for C&I customers will vary. These customers should contact the Company for specific bill impact information.

Due to certain ongoing safety measures and precautions relating to in-person events as a result of the COVID-19 pandemic, the Department will conduct two virtual public hearings to receive comments on the Company's filing. The Department will conduct two public hearings using Zoom videoconferencing:

- Wednesday, December 1, 2021, beginning at 7:00 p.m.
- Thursday, December 2, 2021, beginning at 2:00 p.m.

When using the Zoom platform, you will be able to listen to the hearing and provide comments in English or Spanish. To access interpretation services through Zoom during the hearing, click on the "Interpretation" button on the menu at the bottom of the Zoom application screen and select your language (i.e., English or Spanish).

Alternately, any person interested in commenting on the Company's filing may submit written comments to the Department no later than the close of business (5:00 p.m.) on **Friday, December 3, 2021**. To the extent a person or entity wishes to submit comments in accordance with this Notice, electronic submission, as detailed below, is sufficient.

Any person who desires to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. The following persons/entities who desire to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department not later than the close of business on **Tuesday, November 2, 2021:** (1) voting and non-voting members of the Council; (2) any entity whose interests are represented on the Council; (3) any person/entity that has participated in the Council process; and (4) any person/entity that was previously granted intervention as a full party or limited participant in a three-year energy efficiency plan proceeding. All other persons/entities who desire to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department not later than the close of business on Monday, November 15, 2021. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by the close of business on the second business day after the petition to intervene was filed.

Ordinarily, all parties would follow Sections B.1 and B.4 of the Department's Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)) regarding the filing of documents. However, at this time, all filings will be submitted to the Department only in electronic format, consistent with the Department's June 15, 2021 Memorandum addressing continued modified filing requirements. Until further notice, parties must retain the original paper version of the filing and the Department will later determine when the paper version must be filed with the Department Secretary.

All comments or petitions to intervene must be submitted to the Department in .pdf format by e-mail attachment to <a href="mailto:dpu.efiling@mass.gov">dpu.efiling@mass.gov</a> and <a href="mailto:jeffrey.leupold@mass.gov">jeffrey.leupold@mass.gov</a>. Importantly, all large files submitted must be broken down into electronic files that do not exceed 20 MB.

Petition of Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty, pursuant to G.L. c. 25, § 21, for approval by the Department of Public Utilities of its Three-Year Energy Efficiency Plan for 2022 through 2024.

Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty ("Company"), is required to publish the attached Notice of Filing and Public Hearing ("Notice") on or before **November 9, 2021**, in (1) either The Boston Globe or the Boston Herald; (2) The Fall River Herald News; and (3) the Sun Chronicle.

In addition, the Company is required to serve a copy of the attached Notice on or before **November 9, 2021**, on: (1) the Mayors, the Chairs of Select Boards, the Town Clerks, and the City Clerks in its service territory; (2) the service list in <u>Liberty Utilities (New England Natural Gas Company) Corp.</u>, D.P.U. 18-113 (2019); (3) members of the Energy Efficiency Advisory Council convened pursuant to G.L. c. 25, § 22; and (4) any person who has filed a request for notice with the Company. The Company's service may be by electronic distribution, which the Department finds reasonable and consistent with the public interest.

Finally, the Company shall prominently display the Notice on its website from three business days following receipt of the Notice from the Department through **December 3, 2021**.

The Company shall make proof of publication (including evidence of the required website posting) and return of service by **December 3, 2021**.
